V. Regional Plan Submission Concurrence

The Workforce Innovation and Opportunity Act (WIOA) requires the Governor to designate Regions. WIOA Regions are made up of WIOA Areas. The Upper Shore and Lower Shore areas have been designated as a WIOA Region by Governor Hogan.

The Upper Shore and Lower Shore staff created a draft regional plan for review prior to submission to the Governor's Workforce Development Board. A motion to submit the Shore Regional Plan to the Governor's Workforce Development Board was offered by Gale Collins. A second to the motion was offered by Tom Timberman. The motion was accepted unanimously.

VI. Performance Outcomes Program Year 2019: Joanne Gannon

Each WIB throughout the country is evaluated by state and federal officials on the success or failure in achieving performance measures. The measures may be grouped into broad categories: entered employment, job retention, wage gain and youth measures. Outcomes are measured by validated, supplemental data except for wages which are evaluated based on unemployment insurance records.

The USWIB was successful in exceeding all performance standards for the period July 1, 2019 – June 30, 2020.

A motion to accept the USWIB performance report for the period July 1, 2019 – June 30, 2020 was offered by Tom Timberman. A second to the motion was offered by Gale Collins. The motion was accepted unanimously.

VII. Program Report Title I: Joanne Gannon

Highlights of the Title I program report:

- Intake and eligibility for adult and dislocated worker is being done virtually due to Covid-19.
- Chesapeake College is offering skilled trades classes face to face with Covid-19 safety protocols in place.
- The Upper Shore Scholarship Office/Title I has more Participants in training this year than at the same point last year.
- The Youth program has shifted to an online delivery using a platform that aligns the Workforce Innovation and Opportunity Act required youth elements with competency based modular training components.
- Adult and Youth staff assist Participants with navigating the online and virtual services.
